He then served as an Assistant Prosecutor under Hudson County Prosecutor (later Superior Court Judge), James T. O'Halloran, rising to become Chief Homicide Prosecutor for that office. Mr. Mulcahy joined Flanagan, Barone & O'Brien (f/k/a Purcell, Mulcahy & Flanagan) in 1978, became a named partner in 1980, and served as the firm's Managing Partner from 1984 to 2017.

Mr. Mulcahy has a broad range of litigation and trial experience and is a former certified civil and trial attorney. He has defended corporations in complex product liability suits, multi-party litigation, premises liability accidents, property claims and employment law matters. He has litigated claims in all areas of insurance coverage and policy disputes including first-party property, subrogation, legal, architectural and engineering and

broker/agent matters. Mr. Mulcahy has been frequently retained to investigate and litigate claims involving insurance fraud. He has handled numerous commercial litigation matters including suits against corporate officers, employment-related issues, and commercial transactions.
